RESPONSIBLE CONDUCT OF RESEARCH REQUIREMENTS REMINDER

It is hard to believe that it has been seven (7) months since the Conflict of Interest (COI) and Responsible Conduct of Research (RCR) training requirement went into effect. Evidence of these requirements is **needed at the time the proposal is submitted.** This applies to all new, renewal, continuation or resubmission proposals. To ensure that there are no delays, these requirements must be addressed in a timely manner, as we can no longer submit proposals or activate grants without evidence of these certifications and completed disclose forms. Details about these requirements are listed below:

CONFLICT OF INTEREST (COI)

The COI training requirement applies to Investigators -- project director or principal investigator or any other person regardless of title or position who is responsible for the design, conduct or reporting of the project engaged in funded research. Remember non-CUNY consultants, collaborators and sub awardees are also required to complete this training. Additionally, individuals must also complete either the CUNY Significant Financial Conflict of Interest Disclosure Form for PHS Funded



Research or the CUNY Significant Financial Conflict of Interest Disclosure Form for Research NOT Funded by the Public Health Services for each proposal. These forms can be found on our website at http://research.hunter.cuny.edu/research.compliance.htm.

RESPONSIBLE CONDUCT OF RESEARCH (RCR)

The RCR training requirement applies to CUNY – Faculty, Staff, Post Docs, Pre-doctoral Students, Graduate Students and Undergraduate Students. Individuals can complete these trainings on their own or come to a lab for dedicated time and assistance by the Office of Research Administration.
